Age

e.g. under 16, 16-25 yrs, 25-65 yrs, and 65+

a) negative / adverse / unhelpful impacts, effects or limitations

Persons wishing to be licensed as a taxi driver must have held a full driving licence for 12 months. This prevents 17 year olds from being licensed. However, it also ensures that drivers have had some experience before they take on the responsibility of the safety of fare paying passengers. Therefore it could be argued that this has a positive impact for other road users, the public, passengers and taxi drivers.

b) positive / helpful impacts or effects

Taxis are used by a large number of the most vulnerable members of the community e.g. disabled persons, young persons and children so effective licensing benefits these groups.

Both the Licensing Act and Gambling Act contain specific provision to ensure the protection of children from harm by making sure that they do not access gambling facilities, are unable to purchase alcohol and are prevented from viewing adult entertainment.

Gender

b) positive / helpful impacts or effects

Women aged 16-20 make the greatest number of trip stages in taxis thus effective licensing benefits this group.

Disability

e.g. people with a disability as defined in the Disability Discrimination Act 1995

a) negative / adverse / unhelpful impacts, effects or limitations

Potentially, in some circumstances licence conditions may be necessary for reasons of public safety that have the effect of excluding disabled persons from certain premises. For example, licence conditions may prevent non-ambulant people from entering first floor premises unless an adequate means of escape exist. However, this should be mitigated by the duty placed on premises owners to make reasonable adjustments to premises as required by the DDA.

There are restrictions on having a taxi driver's licence relating to medical fitness. TVBC's policy reflects government guidance that the stricter group 2 licence criteria (for heavy goods and bus drivers) should be applied to taxi drivers. This may lead to the situation where a person who has a car driving licence (based on group 1 criteria), is refused a taxi driving licence (group 2 criteria) because of a disability or illness.

b) positive / helpful impacts or effects

Taxis are used by a large number of the most vulnerable members of the community e.g.

disabled persons, young persons and children so effective licensing benefits these groups. Taxi driver's have a licence condition that they are able to assist a passenger in and out of their vehicle. This has a positive impact for passengers.

Licensing services are delivered in a culture of openness where appropriate information can be accessed by all parties; licensing hearings are generally held in public and any enforcement action is in line with the principles promoted within the national enforcement

Concordat. Partnership working and exchange of information (subject to certain legal constraints) is supported and in this way it is hopped that understanding can be promoted between those who provide and those who use licensed premises, services or vehicles. The Licensing Act 2003 promotes a culture of mediation between applicants and objectors leading to negotiated settlements where possible.
