NOTICE OF MAKING

NOTICE IS HEREBY GIVEN that the Borough Council of Test Valley ("the Council") made the above Order on the 10th day of May 2022 ("the Order") pursuant to the Road Traffic Regulation Act 1984 and the Road Traffic Act 1991 both as amended by the Road Traffic (Permitted Parking Area and Special Parking Area) (County of Hampshire) (Borough of Test Valley) Order 2003. The Order is substantially the same as The Borough Council of Test Valley Off Street Parking Places Order 2021 ("the 2021 Order") with the implementation of proposals numbered 1 to 6 set out in the Notice of Proposals published on 15th April 2022 incorporated. The general nature and effect of the amendments is as follows:

- 1. Clarification that vehicles loading or unloading within the Chantry Centre Service Yards need not be parked within marked parking bays, providing they are not causing any hazard or obstruction.
- 2. The fee for an Alma Road Zone Z Season Ticket permit has been increased to £50.
- 3. Clarification that Unity Minibuses when parking in Shepherds Spring Lane Car Park, Andover may if unavoidable, straddle parking bays.
- 4. The enabling Regulations referenced in the 2021 Order will be updated to reflect that the 2007 regulations will be superceded by new 2022 Regulations from 31st May 2022.
- 5. There is a boundary change to Car Park 61D on the Andover map.
- 6. All other provisions within the Order will remain unchanged.

The provisions within the Order will come into effect on the thirty first day of May 2022.

A notice of proposals in respect of the Order was published on 15 April 2022.

If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Act, or that any requirement of the Act or of any instrument made under the Act has not been complied with, that person may, within 6 weeks from the date the Order was made, apply for the purpose to the High Court.
