RURAL RATE RELIEF SCHEME RURAL SETTLEMENT LIST SECTION 42A LOCAL GOVERNMENT FINANCE ACT 1988

The Rural Rate Relief Scheme only applies to small settlements with a population of 3,000 or less in rural areas. Unless otherwise indicated settlements are based on parish boundaries.

The relief consists of two elements. There is a mandatory element which automatically entitles certain businesses to a 50% reduction in their rates bill. This type of relief applies to:-

- the <u>sole</u> general store, food shop (excluding catering premises) or post office in a qualifying rural settlement, provided that the rateable value of each is £8,500 or less
- the <u>sole</u> public house or petrol filling station in a qualifying rural settlement, provided that the rateable value is £12,500 or less

Test Valley Borough Council also has the discretionary power to grant further relief (up to 50%) to any business in a qualifying rural settlement which the Council believes is of benefit to the local community, provided that the rateable value of each is £16,500 or less, and it is considered reasonable to grant relief having regard to the interest of its' Council Tax-payers.

Attached is a list identifying the qualifying rural settlements in the Test Valley Borough Council area which will take effect for the financial year 2016-2017. The list is reviewed annually and will be published by 31st December each year in respect of the following financial year.
