LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The Test Valley (Reorganisation of Community Governance) Order 2022

Made 23 February 2023

Coming into force in accordance with article 1(2)

Test Valley Borough Council ("the council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated September 2022:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by sections 86, 98(3), 98(4), and 240(10) of the 2007 Act.

Citation and commencement(a)

- 1.—(1) This Order may be cited as the Test Valley (Reorganisation of Community Governance)
 Order 2023
 - (2) Subject to paragraphs (3) and (4) below, this Order comes into force on 1st April 2023.
- (3) Articles 4 and 6 shall come into force on 4^{th} May 2023 being the ordinary day of election of councillors in 2023.
 - (4) For the purposes of:
 - (a) this article,
 - (b) proceedings preliminary or relating to the elections of parish councillors for the parishes of Romsey and Valley Park, to be held on the ordinary day of election of councillors in 2023,

this Order shall come into force on the day after that on which it is made.

Interpretation

2. In this Order—

"borough" means the borough of Test Valley;

"existing" means existing on the date this Order is made;

"map" means the map comprised of a number of sheets each marked "Map referred to in the Test Valley (Reorganisation of Community Governance) Order 2023" and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

"ordinary day of election of councillors" has the meaning given by section 37 of the Representation of the People Act 1983; and

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

Number of parish councillors for the parish of Valley Park

- 4.—(1) The existing wards of the parish of Valley Park shall be abolished.
- (2) The number of councillors to be elected for the parish of Valley Park shall be nine.

Alteration of parish areas

- 5.—(1) The area coloured and designated by the letter "A" on Sheet 1 of the map shall cease to be part of the parish of Romsey Extra and shall become part of the parish of Awbridge.
- (2) The remainder of the parish of Romsey Extra shall cease to be part of the parish of Romsey Extra and shall become part of the parish of Romsey.

Wards of the parish of Romsey and numbers of parish councillors

- **6.**—(1) The existing wards of the parish of Romsey shall be abolished.
- (2) The parish of Romsey (as extended in accordance with Article 5 above) shall be divided into four wards which shall be named as set out in column (1) of Schedule.1.
- (2) Each ward shall comprise the area designated on Sheet 2 of the map by reference to the name of the ward and demarcated by red lines.
- (3) The number of councillors to be elected for each ward shall be the number specified in respect of the ward in column (2) of Schedule 1.

Dissolution of parish council for the parish of Romsey Extra

7. The parish council for the parish of Romsey Extra shall be dissolved.

Abolition of the parish of Romsey Extra

8. The parish of Romsey Extra shall be abolished.

Electoral register

9. The registration officer for the borough shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Transfer of land and property, rights and liabilities

10. The land and property described in columns (1) and (2) of Schedule 2 shall transfer from the parish council of Romsey Extra to the parish of Romsey on 1 April 2023.

Transfer of funds and balances

11. The proportion of the funds and balances described in column (1) of the first table in Schedule 3 shall transfer from the parish council of Romsey Extra to the name of the parish council specified in column (2) of the first table of that Schedule on 1 April 2023.

Order date

12. 1st April 2023 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect to recommendations made by the Borough Council of Test Valley for the abolition of the parish of Romsey Extra and the transfer of part of its area to Awbridge Parish and the remainder to Romsey (Town). Romsey Extra Parish Council is accordingly dissolved. The Order also removes the wards from Valley Park parish, which thereby reverts to being a single unwarded parish.


The changes will come into force from 1 April 2023. The electoral arrangements apply in respect of parish elections to be held on and after the ordinary day of election of councillors in 2023.


Article 6 and Schedule 1 and the map provides for the names and areas of the wards of the revised parish of Romsey (Town) and the numbers of councillors for each ward.

Article 9 obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.
