Given the many changes to the NDP since the Reg 14 consultation, I feel it would have been beneficial for them to have been replayed to the community in better time, perhaps in a different format rather than just a pack of documents, with more time for review of the associated documents and the scope of the changes made.

The NDP is a substantial document and it is not trivial to read or review, particularly when subject to so many changes, and when requested to be read in conjunction with the Test Valley Local Plan (Neighbourhood Plan, page 2) amongst others.

Unlike other elements of demographics (e.g. young children needing school places), would we have different policies if this referenced one or more different skin colours? If not, we should remove it.

Where survey data from the last consultation is used when responding, there are occasions where rather than referring to the survey response, the result is extrapolated to the entire parish population without consideration of any bias in the survey. For example:

"The Parish Survey indicated 94% parishioners in favour"

"is favored by the majority of residents"

Given the small number of responses compared with the total number of parishioners, and the likely (but unquantified) survey biases, it is unclear whether the sample that responded to the survey is representative of the parish population. Therefore, such statements may be stronger than the presented evidence base supports.

As previously noted during the Reg 14 consultation, the proposed housing mix differs from that identified in the Action Hampshire Housing Needs report. As shown in Fig 12, that suggested a breakdown of needs at that point in time of:

- 1 Bed ~5% 2 Bed - ~38%
- 3 Bed ~35%
- 4+ Bed ~22%

It seems that if we are claiming to be working to an evidence base, we should ensure that we are building newer energy-efficient homes in all of these categories roughly according to the demand evidence. Otherwise, a selective approach to the evidence is being taken in not developing for categories surveyed, or only aiming to meeting demand in a category with older, less energy efficient properties.

I reiterate my unaddressed concern from the Reg 14 consultation, where terms are been used which may result in a poor specification for new build properties.

Item 2 – 'superfast broadband' (typically accepted as 24Mbps in the UK) would be most disappointing in new build properties. The preceding text (paragraph 5.16) uses the term 'ultrafast fibre optic'. This should be changed to a different industry term, for example FTTP (fibre to the premises) or FTTH (Fibre to the home) to be clear that leading-edge services are expected.
