The Council will only process your personal data where it is lawful to do so. The Council will process your data in order to communicate with you regarding your application for an Annual Fishing Permit to fish at Rooksbury Mill Local Nature Reserve. The lawful basis for processing your data is that it is with your consent and by returning this form you give your consent. We will not be able to deal with your application to fish at Rooksbury Mill without processing your data.

You can withdraw your consent at any time and ask us to remove you from our records. You also have the right to portability of your data and again, just contact us by the means most convenient for you.

We will not share your information with any third parties. Any information sharing is managed in accordance with data protection legislation. Your contact information will be retained for six years post the issue of your licence and then it will be deleted. We may contact you with regard to any queries about the Fishing Permit and may contact you before expiry of your current permit to invite renewal. We will contact you throughout the season with information regarding fishing and any information regarding your temporary Parking Permit.

The Council will only process your information for the purpose for which it was collected i.e. to process your application for a fishing permit and accompanying parking permit. The Council will not transfer your personal information outside of the European Economic Area (EEA) and will not use your personal information for any automated decision making.
