The Local Plan 2040 Regulation stage 1, section 5.19, talked about the split being 67% Northern Test Valley and 43% Southern Test Valley. Table 5.2 showed that 6167 homes will be built in Northern Test Valley between 2020 and 2040. Members' comments were: "The Highway infrastructure needs to be looked at to accommodate this amount of housing. The current development in Andover Parish, has already put stress on the Highway infrastructure, therefore, this needs to be addressed within the Local Plan to ensure traffic flows smoothly."
