WCC is bringing forward a revised local plan for the district and it is envisaged that the Council will be able to provide the Borough Council with additional information on proposed locations for development later this year, to ensure that further consideration can be given to any cross boundary impacts of development in both authorities.

Paragraph Ref	Specific Comments
2.18	Winchester City Council; supports reference to PfSH in introduction and welcome ongoing engagement on cross-boundary strategic matters.
2.18	Winchester City Council (WCC) notes that the emerging Plan currently provides only for TVBC's current housing need - there is no allowance in the housing figures to accommodate any of the PfSH unmet wider housing need. Whilst discussions are still ongoing and no decisions have been made on how the wider PfSH unmet housing need could be met, TVBC should consider in this Plan how to respond to the issue on the basis that this is likely to be required under the Duty to Cooperate.
2.20	Winchester City Council (WCC) supports the reference to ongoing collaborative work with WCC and others to mitigate the impacts of recreational pressures and nutrients from new development upon the sensitive environment of the Solent, and key infrastructure such as waste water.
Page 29, Test Valley Sustainable Spatial Strategy	Winchester City Council notes the proposed strategy and will consider making further detailed responses once the detail of proposed site allocations is published in the next consultation.
