What is the main purpose of the Service, Strategy, Policy, Practice or Procedure?</p>		<p>East Hampshire District Council, Havant Borough Council, Test Valley Borough Council and Winchester City Council have agreed a common approach for the allocation of social housing across the four local authority areas and together operate a sub-regional choice based lettings scheme called Hampshire Home Choice.</p>
<p>2. List the main activities of the Service, Strategy, Policy, Practice or Procedure.</p>		<p>A person can apply to be registered on the HHC Housing Register. Their application will be assessed to determine if they are eligible and qualify to join HHC. Anyone who is eligible and qualifies for HHC will have their housing need assessed and be placed in the appropriate band. Social housing is advertised on a weekly bidding cycle and applicants can bid for eligible properties. The person with the highest priority due to their housing need followed by the length of time they have been registered on HHC will be offered the property.</p> <p>HHC is currently being reviewed and as a result a number of recommendations have been made. The assessment focussed on the impacts of the criteria for establishing a local connection and prioritising applications.</p>
