<p>We note that the preferred strategy is to defer development policy in many of the villages (Tier 3 and Tier 4 settlements), including Abbots Ann - which is recognised in the evidence base as having all the 'key facilities' for sustainable growth - to community-led initiatives and neighbourhood planning.</p> <p>Notwithstanding, we take the opportunity to confirm that Site 190 (Land southeast of Dunkirt Lane) remains available, and therefore it is appropriate that it has been retained in the latest update of the SHELAA (2023).</p>
