### General

There are about 180 chalk streams **in the world** and the vast majority are in Hampshire and Wiltshire. We, who live and administer the chalkstreams catchment areas are the custodians of this worldwide unique environment.

The chalkstreams live when rainwater falls onto the land and sinks through the purifying chalk to create an aquafer which then erupts from the ground as springs to form the characteristic and unique crystal (gin) clear chalkstreams, rich in invertebrate, flora and fauna.

However, when the catchment area is built on it creates a triple whammy:

1. Rainwater cannot penetrate the concrete and is channelled into drains which overloads the system and allows water companies to discharge untreated sewage into the river system.
2. Flash flooding causes the rivers to spate and the water runs off rather than sink into the earth and down to the aquafer.
3. Water companies are allowed to pour raw sewage into the chalkstreams, adding phosphates and other chemicals which promotes adverse weed, reed and algae growth. With more houses the demand for water grows as does the quantity of sewage so:
4. To cope with the additional demand water companies extract more water thus further denuding the amount of water in the chalkstreams while at the same time discharging more sewage.

In any other place a new build of 8,000 houses (e.g., Micheldever) would be welcomed and, on its own, even in the chalkstream catchment area it might be bearable but – and it's a big but – taken with all the other new build developments in the Test Valley area, e.g., Andover, Ludgershall, Tidworth, Picket Piece, Amport – to name but a few – the effect is devastating. The chalkstream catchment area is being covered in concrete and so deprived of water.

We have SSI's, AOB, National Parks and a host of other environmental protection agencies. What we don't have is a strategy, an awareness, let alone an overarching organisation to protect this unique chalkstream environment that transcends adjoining county boundaries. In consequence the catchment area is being built on piecemeal with total disregard to what is happening in the next county. With increased extraction but without natural replenishment the chalkstreams will be reduced to a dribble and eventually dry up.

At what stage, if any, do planners consider where extra water is coming from and include increased sewage treatment works vis a vis the number of houses being built?

We need to raise awareness of the consequences of disconnected, uncoordinated, haphazard development in this globally unique area to government, county, borough and parish council level. There is room for some development but there needs to be an overarching strategy and awareness in order to limit the development, especially in the feeder streams and river catchment areas if we are to prevent the devastating consequences – the loss of the chalkstreams. There also needs to be thresholds when the total number of houses being planned require the water companies/builders to provide extra water other than extraction and additional sewage treatment works.
