Re: Chilworth & Valley Park - Proposed Velmore Farm development

Having resided in Valley Park for over 20 years, we have witnessed the increase in traffic and congestion due to new housing and commercial developments.

The developments, both large and small, have provided no new highway infrastructure to meet the rising number of vehicles, and have resulted in increasing queues and congestion, particularly in rush hour, including school drop off and pick up.

Templars Way, Chestnut Avenue and Bournemouth Road which serve Asda, the business parks, Village Hotel and the M27, Castle Lane, as well as Leigh Road serving Eastleigh are now so congested that we avoid using these routes at certain times of the day - whenever possible.

The proposed new development, with circa 2000 additional vehicles using the existing local roads can only exacerbate an already dire traffic situation.

Due to the land constraints, it is not possible to significantly improve the highway network in this area. I believe the impact of increased traffic on current roads will be significant, negatively impacting the quality of life in Valley Park.
