| <p>My comments are on Map 35, Ludgershall.</p> <p>This project declares:</p> <p>Land to the East of Ludgershall for 350 homes:</p> <p>My Comments:</p> <p>The project for 350 is ill conceived and not properly thought through.</p> <p>This project will not bring any new benefits to the existing nearby housing developments in Faberstown and Ludgershall which lie within the county of Wiltshire. There are no plans to provide; playparks for children, no community hall projects, no schools (primary or secondary), no doctors/dentist surgeries, no shops/retailers.</p> <p>There is also no plans for utilities such as, power, water supply, drainage, road improvements for the area.</p> <p>There is no name for this particular development in Hampshire, reminder Faberstown is within Wiltshire.</p> <p>What will be lost is I live in Faberstown, the local area provides a sanctuary for birds in particular different species of owls which I hear every night. Also in the summer of an evening we get quite a display of bats. The surrounding wildlife will be lost for good.</p> <p>Land to the South East of Ludgershall for 1,150 homes:</p> <p>The project for 1, 150 is ill conceived and not properly thought through.</p> <p>This project will not bring any new benefits to the existing nearby housing developments in Faberstown and Ludgershall which lie within the county of Wiltshire. There are no plans to provide; playparks for children, no community hall projects, no doctors/dentist surgeries, no shops/retailers. There is plan to build a Primary School, but no Secondary School and no plan as to where the children will go. If the children go to Andover this is more traffic pollution, reminder Wellington Academy is in Wiltshire.</p> <p>There is also no plans for utilities such as, power, water supply, drainage, road improvements for the area.</p> <p>There is no name for this particular development in Hampshire, reminder Ludgershall is within Wiltshire.</p> |

| 4.86 | <p>It states “There will be a need for a co-ordinated approach to the master planning and delivery of these sites from the developers working with Test Valley Borough Council, Wiltshire Council and Hampshire County Council to ensure these sites are comprehensively planned. The masterplan will need to include links between the sites and may provide shared facilities.”</p> <p>I cannot envisage why Wiltshire Council would wish to support these developments as they provide NO benefits to the existing residents of housing within adjacent Faberstown and Ludgershall, both within Wiltshire.</p> |
| 4.103 | <p>It states “Site access is proposed from the A342 (Andover Road) and a bridge would be required over the railway which is used by the Ministry of Defence.”</p> <p>The cost of constructing a bridge of this magnitude for two way traffic and pedestrians on the Hampshire/Wiltshire border will be immense and a massive blot on the existing landscape.</p> |
