#### General

The village of Upton is slowly, bit by bit becoming the town of Upton. The landscape is becoming an industrial estate, a concrete jungle. How on earth does a warehouse fit in along Upton Lane and in order to do this you will be removing a copse full of wild life. What happens to the bats in the area, the bees, the butterflies etc, etc?

We already live by a motorway and 80 houses equals 160 plus cars it is just going to add to the light and air pollution of the area. We are told how important our well being is to avoid mental problems. So, getting rid of our green fields and trees is certainly not going to help with that. I was told by my Doctor that a higher percentage of people in Upton are more likely to suffer from respiratory problems.

We then have the problem of at least 320 extra people needing the services of a doctor, at least 160 children needing school places. We already have to wait 2 weeks for a doctor's appointment. I have to take my grandchildren to Mountbatten school in the morning for their safety because there is not enough room on the bus. Yes, we have informed the school on several occasions but there is nothing they can do about it!

We have no bus service in Upton. We have no footpaths beyond Upton Lane. We have no facilities for young people apart from Gyms.

So, councillors stick up for the people that are already living in Nursling and Rownhams. **NO, NO, NO TO YOUR PLAN.**
