This is essential to keeping the most valued character of our village, and ensuring that the much prized historical nature and identity of our community continues as it has done up to now.</p> <p>Test Valley is nothing if not preserving the beauty and exceptional architecture of our village communities.</p> <p>I have lived in Abbots Ann for 45 years and it is a great place to live with a vibrancy and strength that goes with the many institutions and organisations that have developed here over the years. Therefore keeping a clear boundary between the urban nature of Andover and our village without the inevitable creeping of a housing sprawl is as important now as it has ever been.</p> <p>The Draft Local Plan must be absolutely clear that the Strategic Gap must be preserved for perpetuity, so that subsequent generations are able to experience all that is so good in our village communities like Abbots Ann.</p>
