#### General

The proposed number of 1070 homes will generate at least 2000 vehicles on already overloaded local roads. On a day when there is a problem on the M3 or M27 it is sometimes almost impossible to move for the congestion. Bear in mind that sevarl of the roads near the proposed site form part of a critical incident diversion route.

Most of the new residents will probably gravitate towards Eastleigh, causing additional stress to Eastleigh BC roads and services.

<u>In terms of community services such as doctors and dentists these are already</u> very oversubscribed so a difficult situation will be made even worse.

There is often already severe flooding on the school lane roundabout off which at present the primary access and exit point for the new development will be created. We are aware that for many years investigations on site have failed to determine the exact source of the flooding problem and resolve it. Obviously it is surface water from the site draining down to school lane, and building houses on it is again hardly going to help an already bad situation.

Public transport is a concern as the local bus service is inadequate now, so adding 1070 houses is only going to increase road congestion.

Power pylons run right across the site, and Government recommended approach should be not to build beneath power lines. So will they all be placed underground?

A Roman road runs through the site which presumably will also need to be fully investigated and protected
