| <p><b>Re proposals for Upton Lane, Nursling :</b></p> <ul style="list-style-type: none"><li>- Over development on both counts – housing and employment site – the parish is already 30% over developed against government guidelines.</li><li>-Traffic along Romsey Road is already heavy and at a standstill at peak times.</li><li>- Infrastructure – GP surgeries are currently oversubscribed and appointments extremely difficult to get without adding possibly another 80 households.</li><li>- Local schools are over subscribed</li><li>- Pollution – the area already has a motorway extremely close by.</li><li>- Noise pollution – since lockdown the noise from M27 has increased considerably, I live in Rownhams where we hardly heard the M27, now the noise is constant day and night, new houses built closer to the road will be badly affected by this too.</li><li>- Wildlife in both of the proposed sites will suffer/disappear along with the snowdrops and bluebells.</li></ul> |
