Re-the TVBC leaflet 'Draft Local Plan 2040' we wish to make it clear that the mention of "Land @ King Edward(s) Park for 44 extra care units" is NOT correct! The land is NOT in King Edward Park — it is adjacent to King Edward Park, but has nothing to do with K.E.P!! Very misleading!! It is part of the huge (and overwhelming!) 'Retirement Village' which seems to overlook us and the houses in Flexford Close — I could not believe how overbearing this development is!!

Also, we have seen that some 'tree stumps' have been 'dumped' in the field, near to K.E. Park — we have been told they were "dumped" there as they were 'contaminated' with 'ASBESTOS'?? Why haven't they been dealt with properly — they are an eyesore for us!! — and seemingly dangerous?? due to the "water runoff" from that field into K.E.P.
