Development of 340 houses south of Kings Chase – I do not support the inclusion of this proposed development within the local plan for the following reasons:

- The land is currently countryside. There are existing brownfield sites that could and should be developed in Romsey as a higher priority.
- The proposed vehicle access to the land is unsuitable both through Scorey's Crescent and along Ganger Farm Way, particularly given the existing traffic issues on the weekend associated with the Sports Park.

The Hilliers Brentry proposal would appear to be a better alternative as the development would occur on brownfield land, has its own separate access onto Jermyn's Lane and also provides better footpath access to Ampfield Wood from the existing Kings Chase development.
