General – PLANNING PERMISSION

You will be aware that the Environment Agency (EA) has recently objected to a planning application for new houses in Oxford because the water company cannot cope with the extra sewage. Long and expensive litigation will undoubtably follow which will benefit no one.

You will also be aware that Southern Water has not only been fined for discharging sewage into the river Test and other chalkstreams but continues to do so. Clearly, they cannot cope with the current demand either and will be unable to do so for at least another decade. It is likely the EA will object to planning applications in this area for the same reason.

Southern Water are also over abstracting water from the aquifer, their only source of fresh water, which inevitably leads to hosepipe bans and devastation to our rivers.

A possible solution would be to stipulate that new dwellings have self-composting toilets. It will save sewage being discharged into our rivers and also save water -a gallon a flush.

The scheme would need to be carefully thought through – how to deal with waste disposal and processing as either compost/fertilizer or fuel but surely within the capability of the water company.
