1. There is an issue of flooding in the area. This needs to be investigated and solved prior to any building taking place.
2. Will there be new balancing ponds to take account of flooding?
3. There appears to be only one main exit/entry to the estate via Templars Way. Why is there no exit/entry for vehicles in Chllworth?
4. It is mentioned there will be a Junior school as part of the estate, however the two Junior schools in the area are reducing staff numbers due to a decrease in student numbers. Has this been considered.
5. The area is short of doctors and dentists but no mention is made of extra facilities on the estate This will make worse an already major problem for the area.
6. What happens to the farm, I believe it is still a going concern and that farm land is needed.
7. The pylons would have to be moved underground has this been considered and how does it affect the properties being built.
8. Green space is being given up for buildings, what plans are there for Valley Park residents and their needs for recreational ground?
9. There needs to be additional local shops and community centre for the estate, has this been considered?
10. Also will there be new recreational/play areas as part of the plan?
