Appendix IV Site reference / SHELAA No: /	<b>Velmore Farm. Valley Park</b>  <b>OBJECTIVE 10</b>  The narrow corridor of varied woodland surrounding the public footpath on the western boundary of the site is important for bio diversity and should be left as it is and not part of the area for proposed development. It is an important wildlife corridor between Hutwood and Great Covert.  <b>OBJECTIVE 6</b>  The land on the proposed site is elevated above the existing housing in Valley Park by as much as 20m. A small stream draining this area presently passes through the Valley Park residential area to eventually flow into Monks Brook. The runoff from the proposed development could lead to flooding in the future, especially if Climate Change leads to heavier rainfall. Existing flooding in School lane/Templars Way proves the vulnerability of the area.
