Policy BI01 and paras 4.165-4.169	<p>I support the exclusion of land between Cupernham Lane and Fishlake Meadows Nature Reserve from development. There have been attempts to secure further residential consents , for example on land north of Oxlease Meadows, in contravention of existing Local Plan policy and I think it is important that this policy is maintained in the 2040 Local Plan.</p> <p>The current open nature of that land provides an important connection to countryside to support the wellbeing and diversity of wildlife. Development would also adversely impact on human amenity - the walk along the canal path is delightful, albeit impacted by housing to the east, and yet more development adjacent to the barge canal should be resisted. Walking through the land north of Oxlease Meadows I have heard woodpeckers and also the sound of a bittern from the reserve - it would be sad to lose that opportunity.</p> <p>There is no need to allow further housing west of Cupernham Lane, since proposed strategic housing allocations (paras 4.165-4.169) in the Draft Plan cater for Romsey's needs, and there is still an allocation within the current Local Plan that has not been taken up.</p>
