	The current junction from Ganger Farm Way to Jermyns Lane is subject to surface water flooding from Jermyns Lane, where passing vehicles (on Jermyns Lane) create a tidal effect down Ganger Farm Way. The splay of the junction is already narrow with vehicles entering Ganger Farm Way partly on the wrong side of the road. At weekends, overflow vehicles from the sports pavilion park along the road creating a very dangerous single lane effect on the road which would make access for emergency vehicles difficult even with the current number of vehicles. The play area, sited on a section of road which both floods and attracts parked vehicles, makes children very vulnerable. Neither the junction or road are suitable for a higher volume of traffic.
