I would like to place an objection to this being on the plan.</b></p> <p><b>This and would be accessed via an already over used, and at times, inaccessible route. Traffic here is particularly bad at weekends and evenings, meaning that we have some difficulty getting off our drive/ out of the estate at times. Should there be a significant increase in traffic, by the proposed houses, this would only worsen. The entrance to the estate in particular bends in such a way that it is effectively a blind corner for the first 200m of the road when people park there. It is unsafe for car drivers and path users as car drivers tend to use the 4th next to the football field to drive on t these times.</b></p>
