Representations on the Draft Test Valley Borough Local Plan 2040 Regulation 18 Stage 2

These representations have been prepared by Southern Planning Practice Ltd on behalf of Yelspa Ltd which owns and runs a Biodigester Plant on land at Faulkners Down Farm, Picket Piece at in response to the current consultation on the Draft Local Plan 2040 (hereinafter referred to as the DLP).

Chapter 5: Theme Based Policies

Policy CLI: Countering Climate Change

This general and overarching policy is **supported**, in particular criteria c) which reads as follows:

"c) Development, including associated facilities and infrastructure, is **designed to be adaptable** to **changing needs**, technologies, and a changing climate";

The policy wording also states that:

"Appropriate opportunities have been taken to **use or reuse buildings and land efficiently**, minimise the use and promote the sustainable use of resources and promote a circular economy".

There should be stronger wording in this policy to demonstrate a presumption in favour of allowing the principle of such development that counters climate change, unless there are significant adverse impacts.

To increase the potential to reduce emissions by 2050, further changes are required to other relevant draft local plan policies in this chapter, namely;

Policy CL5: Renewable and Low Carbon Energy

This draft policy supports the delivery of renewable and low carbon energy and storage along with the associated infrastructure.

There are many sites that have been planned for the long term, not just on the basis of a 25year licence. There should be greater support to sustain these sites, given the level of investment and potential benefit for the climate in the future in accordance with criteria a) paragraph 160 of the NPPF.

In terms of the de-commissioning of sites, it seems onerous to have to consider traffic implications, when it would seem obvious the traffic generation would be less if the activity or land use were to cease. The impact on local amenity would also be reduced. There is little in the policy commentary to explain why criteria g) should also comply to decommissioning.



The requirement for restoration and re-instatement of sites following the cease of operations in the second paragraph of the policy wording is considered to be unnecessary. The need to re-instate any lost habitats is appreciated and acknowledged as of great importance.

Paragraph 157 of the NPPF sets out how the planning system should "encourage the reuse of existing resources, including the conversion of existing buildings; and support renewable and low carbon energy and associated infrastructure". The potential for re-use and re-development for other forms of renewable and low carbon energy forms should therefore be more strongly encouraged and supported through the wording of draft policy CL5. This would result in more efficient use of land and reduce the need to look for other alternative sites for this type of provision.

There is little consideration for the existing sites within the Borough that currently deliver renewable and low carbon energy in the policy wording. This is likely due to the lack of detailed assessment of the existing provision and potential development opportunities of those sites in The Test Valley Renewable and Low Carbon Energy Study (2020). significant weight should be given to the benefits of utilising an established site in accordance with criteria c) paragraph 163 in the NPPF. Proposals for the repowering and life-extension of all types of for renewable and low carbon development should be included, not just 'wind energy proposals' as listed under criteria h) of policy CL5.

Given renewable and low carbon technology is constantly evolving at a rapid pace, the potential for amendments, revisions and extensions to existing schemes should be considered and strongly supported in policy.

Summary

There should be greater emphasis on supporting development that is ancillary to, an expansion or re-use of existing sites that generate renewable and low carbon energy. This will maximises the potential for suitable development, and their future re-powering and life extension of existing sources of renewable and low carbon energy sources across the Borough.
