Your application **MUST** include the items listed under National Requirements. It must also include those under Local Requirements where relevant. Any missing requirement could delay the validation of your application.

A plan which identifies the land to which the application relates and showing the direction of North, drawn to a scale of 1:1250 or 1:2500 with the application site outlined in red (original plus three copies to be supplied unless the application is submitted electronically)	
A copy of other plans and drawings or information necessary to describe the subject of the application (original plus three copies to be supplied unless the application is submitted electronically) including:	
<ul style="list-style-type: none"> <li>Block plan of the site at a scale of 1:200 or 1:500 showing any site boundaries</li> </ul>	
The completed Ownership Certificate and Agricultural Land Declaration (A, B, C or D – as applicable) as required by Article 7 of the Town and Country Planning (General Development Procedure) Order 1995	
Design and Access Statement (see separate explanation)	
The appropriate fee (see Fees list)	
In addition, where Ownership Certificates B, C or D have been completed, notice(s) as required by Article 6 of the Town and Country Planning (General Development Procedure) Order 1995 must be given and/or published in accordance with this Article

<ul style="list-style-type: none"> <li>• Amount of development – the amount of development proposed for each use</li> </ul>			
<ul style="list-style-type: none"> <li>• Indicative Layout - the approximate location of buildings, routes and open space and, where appropriate, identifying any separate development zones proposed within the site boundary</li> </ul>			
<ul style="list-style-type: none"> <li>• Scale parameters - the upper and lower limits of height, width and length of each building</li> </ul>			
<ul style="list-style-type: none"> <li>• Indicative Access Points - the area(s) in which the access point(s) to the site will be situated</li> </ul>
