Housing Occupations

Latest figures obtained from the developers' sales offices showed that as of end April 2012, just under 100 homes were occupied at P20. This figure includes private homes and housing association properties.

P20 Facilities

As part of the S106 legal agreement, the developers will provide 3 hectares of land for a local centre site for community facilities which will include:

Community Centre,
Retail Shop, Day
Nursery, GP / Health
Centre, Public House.



This land is marketed by the developers and tenders are submitted by any interested parties from 250 occupations.

- ** A permanent community centre at P20 is expected by the time 400 homes are occupied.
- ** A temporary portakabin has been provided for us to use as a community centre until the permanent centre is ready and that will be situated at Turnpike Road, hopefully by the end of May 2012.
- ** A MUGA (multi use games area) play area will be situated at the school site.
- ** An Urban Park area will comprise of 7 football pitches, a cricket pitch, pavillion - changing rooms, tennis court and public open space - this is at 400 occupations.
- ** Informal recreation areas and equipped play areas will be provided through-out the development as the number of occupations grow.
- ** The Bus and Cycle Underpass is under construction and is expected to be open in October 2012. Public art will decorate the underpass.
- ** A footbridge will be constructed to link P20 with Ladies Walk and should be in place by 275 occupations. Public art, commissioned by Persimmon, will feature on the bridge.
- ** Construction of a roundabout on the B3400, to allow additional access to P20 is expected to start July 2012.

Community

Community Centre

A temporary community centre at P20 will be open soon at Turnpike Road. We are planning to hold an Opening Event some time in June. We will be able to use the temporary community centre as a venue for information about the development, local facilities, services and community activities in and around Andover. Also we plan to set up a resident coffee group for neighbours to meet each other.

A permanent community centre will be provided by the developers once 400 homes are occupied.

Naming the local streets at P20

Street names can identify themes which have some reference to a site, its characteristics and history. Following research and having regard to the existing street names in Andover, the following themes were considered for P20.

Coaching / transport (used, so far, for street names in Phase 1A)

The site adjoins the former Turnpike Road from Andover to London, hence London Road. Street names were considered around the people and activities associated with Andover's role as an important link in the network of routes serving the area.

Horse racing (will be used for street names in Phase 1B)

There is evidence that a race course was located on the site in the late 1700s.

Harewood Forest

Adjoining the site is Harewood Forest. In addition to possibly using variety names of trees and woodland plants associated with the forest, the area has a rich history particularly with respect to the stories surrounding English royalty in the late Saxon period.

Field and Farm Names

There is information on the tithe maps for the area relating to old farm and field names.

Currently we have the following street names within the Phase 1A Development:

Phase 1A

Boulter Road & Boulter Crescent -

This is named after a local highwayman called Thomas Boulter who was renowned for holding up the coaches between Southampton and Salisbury and from London to Salisbury particularly as they travelled over Salisbury Plain who was hanged in Winchester in 1778 aged 30, known as the "Flying Highwayman of Wiltshire".

Defiance Way - This is named after the Defiance Coach that went from London to Exeter in the 1830's where the Coach stop prior to and from London was Andover.

Quicksilver Way - This is the name of another coach from Exeter to London which was deemed to be the fastest coach in England in 1844 taking 17 hours from London to Exeter.

Tollhouse Close - Named from the use of Tollhouses over different lengths of roads

Turnpike Road - Named from the originally maintained roads known as turnpikes, one of which the Winchester to Andover Turnpike passed close by going through Wherwell, originating from the Turnpike Act of 1773.

When the roads are adopted by TVBC on the P20 development, rubbish bins will be provided. Until that time please take your dog's mess home with you to dispose of.



Disposing of rubbish

TVBC collect kerbside rubbish from P20 properties on Wednesday's, alternating between household waste (black bin) and recycling (brown bin). Please leave your bin at the edge of your property by 7am and bring back onto your property as soon as possible once emptied.

Rubbish can also be taken to the Household Waste Recycling Centre at Scott Close on Walworth Business Park.

Travel Survey

As new residents living in Andover, you hold vital information about the travel needs of the community. We very much appreciate your time and effort in helping with this survey. There will be a prize for one completed, returned survey drawn at random.



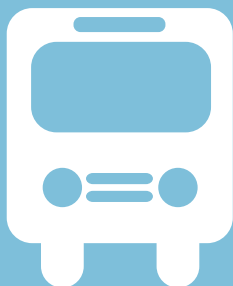
Health Walk – May 29th

Travelling by bus

As the development grows, there will be a designated bus route servicing P20 and picking up at points throughout the development to travel to the town centre. The Bus and Cycle Underpass is under construction and is expected to be open in October 2012.

Construction of the London Road roundabout is expected to start 8 July, 2012.

Car Sharing



Car sharing is when two or more people share a car and travel together. Car sharing is a simple way to cut the costs of fuel and parking, cut congestion and pollution, and cut the stress of driving.

You can obtain a free car sharing account via hantscarshare.com, connecting you to like minded individuals, wishing to see a reduction in traffic in Hampshire as well as reducing travel costs. There are currently 379,233 members registered with the national liftshare network and on average they each save £786.38 per year.

Parking

Households on P20 have allocated parking spaces and residents should use these to park their vehicles.

Cars parked on pavements make it difficult for pedestrians to walk safely and can be dangerous especially for children. Emergency services such as fire engines could also find it difficult to access some roads / houses, where residents have parked inconsiderately.

Education

The construction of Pilgrims Cross Primary School at P20 is due to start in the Autumn of 2012 and the school is expected to open in September 2013 for ages 4 – 11 year olds with an admission of 30 pupils.
