1.0 Introduction

- 1.1 This Basic Conditions Statement has been prepared by the South Downs National Park Consultancy Services on behalf of Thruxton Parish Council. It accompanies the Thruxton Neighbourhood Development Plan (NDP) 2019-2029 that has been submitted to Test Valley Borough Council.
- 1.2 The purpose of this statement is to demonstrate that the Thruxton NDP meets the legal requirements for a Neighbourhood Plan and the four basic conditions as set out in paragraph 8(2) of Schedule 4B to the Town and Country Planning Act 1990 (as applied to Neighbourhood Development Plans by section 38A of the Planning and Compulsory Purchase Act 2004).

1.3 The four basic conditions are:

- having regard to national policies and advice contained in guidance issued by the Secretary
 of State, it is appropriate to make the neighbourhood development plan,
- the making of the neighbourhood development plan contributes to the achievement of sustainable development,
- the making of the neighbourhood development plan is in general conformity with the strategic policies contained in the development plan for the area of the authority (or any part of that area),
- the making of the neighbourhood development plan does not breach, and is otherwise compatible with, EU obligations.

1.4 The Statement confirms that:

- The legal compliance requirements have been met (section 3);
- The NDP has had due regard to national policies and advice contained in guidance issued by the Secretary of State (section 4);
- The NDP contributes to sustainable development (section 5);
- The NDP is in general conformity with the strategic policies contained in Test Valley Borough Council's Adopted Local Plan 2011-2029 (section 6);
- The NDP does not breach and is otherwise compatible with EU obligations, and that its making is not likely to have a significant effect on a European site, either alone or in combination with other plans or projects (section 7).

2.0 Background

- 2.1 Work began on the Thruxton NDP in 2016 with the formation of a steering group made up of local residents and Parish Councillors.
- 2.2 The key motivations for preparing the NDP was to ensure that the Parish Council, with support from the community, was able to retain influence over the future development of the parish. Importantly, the Steering Group was keen to create a plan that is a 'Parishioners' Plan' reflecting what the community had told them in a way that meets the requirements of

the Neighbourhood Plan process.

- 2.2 The NDP has been prepared to be in general conformity with the relevant development plan polices. The Test Valley Revised Local Plan (2011-2029) was adopted by the Borough Council in January 2016 and includes strategic policies and a number of allocations as well as development management policies. Hampshire County Council's Minerals and Waste Plan 2013 is also part of the Development Plan and contains planning policies for minerals and waste development in Hampshire. This plan does not contain any policies directly relevant to the Thruxton NDP.
- 2.3 A screening opinion request was made to Test Valley Borough Council as to whether Strategic Environmental Assessment (SEA)/Sustainability Appraisal (SA) and or Habitats Regulations Assessment (HRA) were required. Test Valley Borough Council confirmed, following consultation with Natural England, Environment Agency and Historic England, that Thruxton NDP would not be likely to have significant environmental effects. With regards to the Habitats Regulations Assessment and whether an Appropriate Assessment is required, the Council concluded that the proposed Neighbourhood Plan is not likely to have a significant effect on European designations. This is supported by the response from Natural England. Further details with respect to this are set out in section 7 of this document.

3.0 Legal Compliance Requirements

- 3.1 The NDP relates to the area that was designated by Test Valley Borough Council as a Neighbourhood Area on 10 May 2015. The NDP relates only to this Area. No other Neighbourhood Development Plan has or is being made for the Area.
- 3.2 Thruxton Parish Council is the qualifying body.
- 3.3 The NDP is a plan which sets out policies in relation to the development and use of land in the Neighbourhood Area and which has been prepared in accordance with the statutory provisions.
- 3.4 The NDP specifies the period for which it is to have effect, which is 2019-2029.
- 3.5 The NDP does not include provision about development that is excluded development, such as mineral and waste matters, nationally significant infrastructure projects or other prescribed development under section 61K of the Town and Country Planning Act 1990.

4.0 Conformity with National Policies and Guidance

4.1 National planning policy is set out in the National Planning Policy Framework (NPPF). The original NPPF was published in March 2012. It was replaced in July 2018 by a revised and updated version. Paragraph 214 of the revised NPPF provides that the policies in the previous Framework will apply for the purpose of examining plans, where those plans are submitted on or before 24 January 2019. It is envisaged that the Thruxton NDP will be submitted to the Local Planning Authority by this date. Accordingly, this Basic Conditions Statement confirms

that it is appropriate to make the NDP having regard to the policies of the March 2012 Framework. All references in the main text to NPPF paragraph numbers are to the March 2012 Framework.

- 4.2 This NDP has been prepared with the policies and guidance contained within the National Planning Policy Framework (NPPF) at its core.
- 4.3 The NPPF sets out more specific guidance on neighbourhood plans at paragraphs 183 to 185:
 - NPPF paragraph 183 gives communities direct power to develop a shared vision for their neighbourhood and deliver the sustainable development they need. Thruxton Parish Council has used its neighbourhood planning powers to develop a vision for the Neighbourhood Area and to set planning policies in the NDP.
 - In relation to NPPF paragraph 184, the NDP is in general conformity with the strategic
 policies of the Adopted Test Valley Local Plan 2011-2029.2 The NDP reflects the
 strategic policies and positively supports them. The general conformity of the NDP with
 the strategic policies of the Adopted Local Plan is set out in more detail in section 5
 below.
 - In line with NPPF paragraph 185, the NDP shapes and directs sustainable development in the Neighbourhood Area, through the provision of a balanced set of objectives and policies which deal with social, economic and environmental matters.
- 4.4 Set out below are the policies contained within the Thruxton Submission NDP, cross referenced to national policies and guidance, to demonstrate how they have had regard to this. It should be noted that the table below is not exhaustive and there may be other cross-references that are not included in the table below:

5.0 Contribution to Sustainable Development

- 5.1. Sustainable development is defined as 'development that meets the needs of the present without compromising the ability of future generations to meet their own need'. It is about ensuring better quality of life for everyone, now and for generations to come. In doing so, social, environmental and economic issues and challenges should be considered in an integrated and balanced way.
- 5.2. The NPPF states the Government's intentions with regards to sustainable development, in particular the need for the planning system to perform a number of roles:

ECONOMIC ROLE – contributing to building a strong, responsive and competitive economy, by ensuring that sufficient land and the right type is available in the right places and at the right time to support growth and innovation; and by identifying and coordinating development requirements, including the provision of infrastructure.

SOCIAL ROLE – supporting strong, vibrant and healthy communities, by providing the supply of housing required to meet the needs of the present and future generations; and by creating a high quality built environment, with accessible local services that reflect the community's needs and support its health, social and cultural well-being.

ENVIRONMENTAL ROLE – contributing to protecting and enhancing our natural, built and historic environment; and, as part of this, helping to improve biodiversity, use natural resources prudently, minimise waste and pollution, and mitigate and adapt to climate change including moving to a low carbon economy.

5.3 The Vision, objectives and policies of the NDP have these three roles at their heart:



Economic

- 5.4 The parish contains a variety of industrial, storage and business uses as well as areas of agricultural activity. These uses are an important part of the local economy and provide the opportunity for people to work in the local area. The Thruxton Neighbourhood Plan has the economic objective of promoting a strong economy by maintaining and enhancing, where possible, existing employment uses.
- 5.5 The key employment area is Thruxton Airfield and Industrial Estate which currently contains 17 businesses with a particular focus on vehicle repair, engineering, motorsports and aviation. There are also a number of homeworkers that either work from or run small businesses from their home. Most of the agricultural activity is based on Thruxton Down. The Test Valley Local Plan contains a range of policies relating to the use and re-use of employment premises. These are therefore not repeated in the Neighbourhood Plan to avoid duplication as they will apply to any relevant planning applications. Instead the Thruxton NDP aims to recognise the important of motor sports and aviation to the parish both at a local level and national level and contains a policy specific to the Thruxton Airfield site.

Social

- 5.6 Thruxton Parish, especially the village, has a strong community spirit with many community events running throughout the year. However, the parish has a relatively limited range of community facilities. The risk of losing these is therefore a key consideration of the Thruxton NDP.
- 5.7 The social objectives include: supporting small scale residential development within the settlement boundary where it meets the need for smaller homes; ensuring that new development provides an appropriate mix of housing which meet the needs of the community, including the ageing population; seeking improvements to infrastructure; protecting and where possible enhancing existing community and recreational facilities; and pursuing improvements to public/pedestrian safety.
- 5.8 The plan also through some of its environmental objectives seeks to protect the distinctive character of the parish aiding a sense of place and fostering community identity. The NDP, in addition, designates and protects Local Green Spaces which provide visual amenity and recreational value and also safeguards public rights of way which contribute to health and wellbeing.

Environmental

5.9 The first part of the Vision of the NDP is that by 2029 the diverse landscape and heritage of the Parish will have been conserved and enhanced. Its rural feel and character will remain. Key objectives include: seeking to preserve the open chalk landscape and key views; conserving a sense of remoteness and tranquillity; retaining the distinctive settlement pattern; protecting flora, wildlife habitats and biodiversity, including Pillhill Brook and looking at opportunities for wetland creation; protecting important areas of open space and designating Local Green Spaces; protecting trees and hedgerows and promoting native planting; and mitigating the

- impacts of air, light, noise and water pollution; providing for the conservation and enhancement of heritage assets and requiring proposals to be of a high quality design.
- 5.10 Other NDP policies support the environmental role indirectly. Policies addressing the social role help to protect important open spaces for formal and informal recreation. Policies addressing the economic role support the continued delivery of goods and services locally, reducing the need to travel.

Contribution to Sustainable Development

- 5.11 There is no specific legal requirement within the Regulations for Neighbourhood Development Plans to undertake their own Sustainability Appraisal (SA) and in this instance one has not been prepared following a screening opinion from the Test Valley Borough Council that Strategic Environmental Assessment was not required.
- 5.12 The Submission NDP sets out a clear sustainable framework for future development within the Parish. The plan has been prepared with the sustainability issues affecting the village being a central consideration as the decision making process of the Steering Group has involved considering a range of options for inclusion in the NDP and incorporating the most sustainable ones.
- 5.13 The matrix below identifies which roles of sustainable development each policy contributes towards or detracts from.

6.0 General Conformity with the Strategic Policies in the Development Plan

- 6.1 The Neighbourhood Plan needs to be in general conformity with the strategic policies of the development plan. As the Parish is located within Test Valley Borough the development plan consists of:
 - The Test Valley Revised Local Plan (2011-2029). The Local Plan was adopted by the Borough Council in January 2016 and includes strategic polices and a number of allocations as well as development management policies. This NDP has had due regard to relevant policies and evidence supporting the Test Valley Local Plan.
 - The Hampshire Minerals and Waste Plan 2013. This Plan contains planning policy for minerals and waste development in Hampshire and therefore is not of direct relevance to the Thruxton NDP.
- 6.2 When considering whether a policy is in general conformity a qualifying body, independent examiner, or local planning authority, should consider the following:
 - whether the neighbourhood plan policy or development proposal supports and upholds the general principle that the strategic policy is concerned with;
 - the degree, if any, of conflict between the draft neighbourhood plan policy and the strategic policy;
 - whether the draft neighbourhood plan policy or development proposal provides an additional level of detail and/or a distinct local approach to that set out in the strategic policy without undermining that policy;
 - the rationale for the approach taken in the draft neighbourhood plan and the evidence to justify that approach.
- 6.3 Paragraph 156 of the National Planning Policy Framework sets out the strategic matters which local planning authorities are expected to include policies in their Local Plans. Strategic policies aim to deliver:
 - the homes and jobs needed in the area;
 - the provision of retail, leisure and other commercial development;
 - the provision of infrastructure for transport, telecommunications, waste management, water supply, wastewater, flood risk and coastal change management, and the provision of minerals and energy (including heat);
 - the provision of health, security, community and cultural infrastructure and other local facilities; and
 - climate change mitigation and adaptation, conservation and enhancement of the natural and historic environment, including landscape.
- 6.4 The table below explains how the Thruxton NDP is in general conformity with the strategic policies of the Test Valley Local Plan 2011-2019. The strategic policies are identified in Annex A to the Adopted Local Plan. The NDP also supports the delivery of other non-strategic

adopted Local Plan Policies. Table 3 explains how each of the NDP's policies align with the strategic and other policies of the Local Plan. :

7.0 Compatibility with European Union Regulations

Strategic Environmental Directive and Habitats Directives

- 7.1 In January 2018 Thruxton Parish Council made a request to Test Valley Borough Council as the responsible authority to determine whether or not a Strategic Environmental Assessment (SEA) and/or a Habitats Regulations Assessment (HRA) were required for the NDP. A Briefing note was provided to the Borough Council in support of this request. Natural England, Historic England and the Environment Agency were consulted in accordance with the regulations. The Borough Council concluded that:
 - The NDP would not be likely to have significant environmental effects and that on this basis SEA would not be required;
 - The proposed NDP is not likely to have a significant effect on European designations and therefore HRA would not be required.
- 7.2 A statement has been prepared by the Borough Council setting out its reasons for the determination, in accordance with the regulations. The full Statement with Annexes which include the Briefing Note provided to the Borough Council may be seen at https://www.testvalley.gov.uk/planning-and-building/planningpolicy/neighbourhood-planning/thruxton-parish-nhp
- 7.3 The requirements of the SEA and Habitats Directives are considered therefore to have been met.

Water Framework Directive

- 7.4 Adopted Local Plan policy E7 requires that development proposals do not result in the deterioration of, and where possible assist in improving water quality and be planned to support the attainment of the requirements of the Water Framework Directive. Local detail is added to this strategic policy by NDP policy EN5: Pillhill Brook which is a tributary of the River Test. This supports the achievement of ecological status objectives for the River Test, as set out in the Environment Agency's South East River Basin Management Plan 2015 in furtherance of the Water Framework Directive.
- 7.5 The NDP will support the attainment of relevant environmental objectives and is considered therefore to be compatible with the Water Framework Directive.

Human Rights

7.6 The NDP is fully compatible with the European Convention on Human Rights, transposed into UK law by the Human Rights Act 1998. It has been prepared within the existing framework of statute, national planning policy and guidance, and Borough-level strategic planning policies. In accordance with established process, its preparation has included consultation with the local community and it is subject to independent examination. The policies within the Plan are considered to comply with the requirements of EU obligations in relation to Human Rights.
