It has been formally agreed that Test Valley Borough Council is the lead Local Council and that West Tytherley-Frenchmoor-Buckholt Parish Council is the lead Parish Council.

5) For all applications

The joint NDP area was originally agreed to cover the two parishes of West Tytherley and West Dean because the latter village and conservation area is split by the county boundary. Also, the two rural villages and surrounding area were part of a single estate and have complementary heritage. The area needs to be re-designated as part of the Community Governance review undertaken by Test Valley Borough Council. In 2018 Buckholt was identified as a parish without a parish council or an active parish meeting. The outcome of the process is that in May 2019 Buckholt joined the existing "Group" of the parishes of West Tytherley and Frenchmoor to form the West Tytherley-Frenchmoor-Buckholt Parish Council. The residents of Buckholt were consulted as part of the Regulation 14 consultation, and responses were received. Including Buckholt within the designated area will ensure that the plan boundary is coterminous with the amended parish boundary.

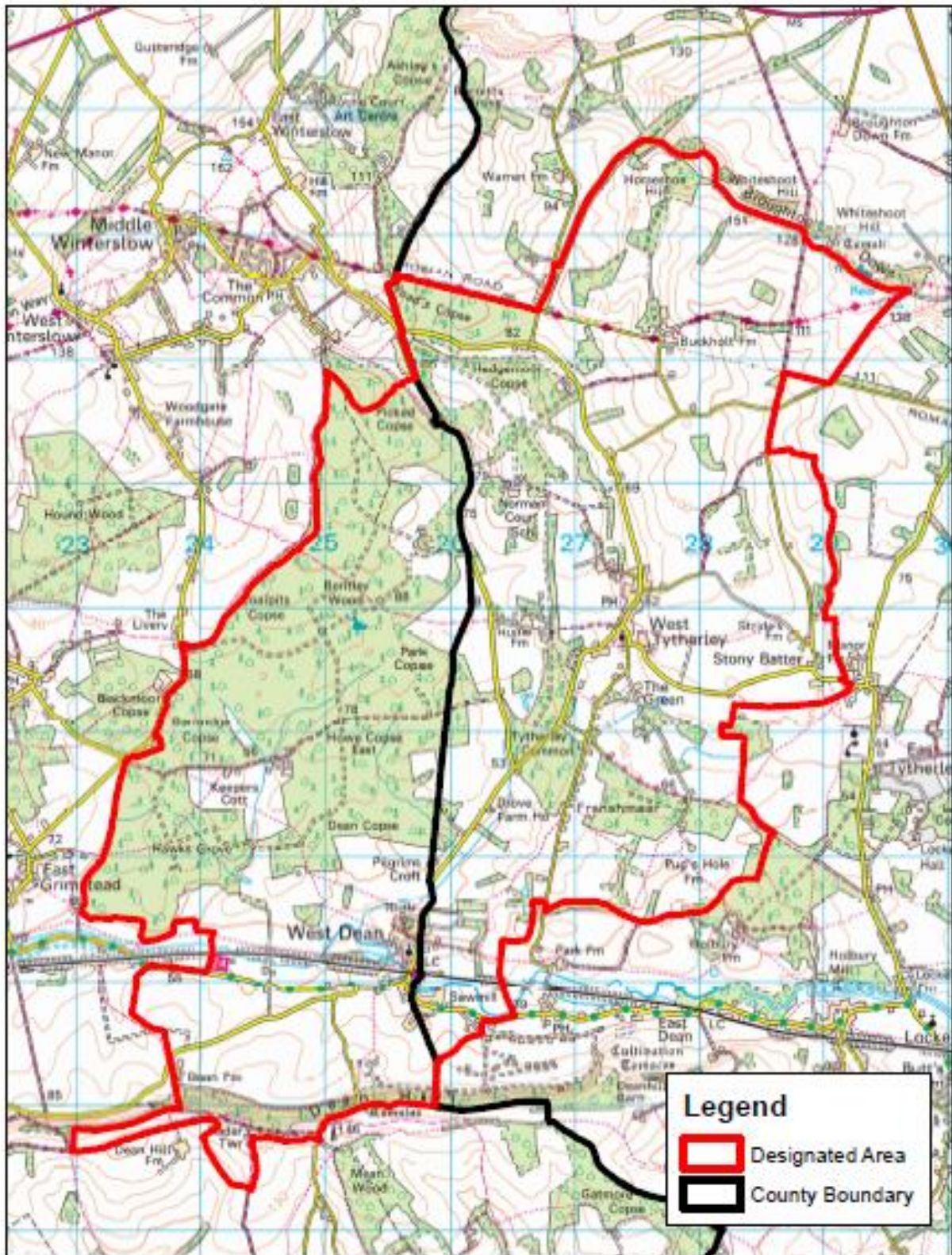
